#### Construction activities beginning the week of December 18

King County's contractor for the Magnolia Conveyance Project will be installing another pipe to connect to the Magnolia Wet Weather Facility in Smith Cove Park. Over the next several months, crews will be working in the Smith Cove Park area and 32nd Avenue West.

### Smith Cove Park - Work underway

Crews are preparing to excavate and install ground support near the entrance of the existing pipe in the southwest corner of the Smith Cove Park. People visiting the park can expect the following:

- Construction activities Monday through Friday from 7 a.m. to 6 p.m. and Saturday from 9 a.m. to 6 p.m.
- Construction equipment mobilized onsite such as drill rigs, trucks, and excavators
- Excavation and installation of shoring boxes
- Increased noise and vibration in the work area
- Traffic control personnel and signs to direct traffic and pedestrians around the work zone, as necessary

People will still be able to use the north athletic field.

## 32nd Avenue West – Landscape salvage in December, construction begins in January

Starting as early as January 2, crews will begin to mobilize the work area on 32nd Avenue West. During the week of December 18, landscapers will

remove some shrubs and trees that were planted as part of the previous project. These plants will be transplanted on other King County property, and the pla replaced in this work area before construction is completed. .

- Landscape crews salvaging plants on December 19 and 20
- Construction fencing and site mobilization starting January 2
