Progress update and reminder about project updates

King County's contractor is preparing to close the portion of 32nd Avenue West between Clise Place West and 33rd Avenue West. The contractor will begin setting up the area on Friday, but may be able to keep that section open until March 5. Next week, they will begin delivering pipe sections for the fusion process. This week, crews will continue using soil freezing equipment in Smith Cove Park.

Construction activities on 32nd Avenue West

Pipe delivery will begin the week of March 5. Pipe fusion will continue for about four weeks.

Residents on 32nd Ave. W. can expect:

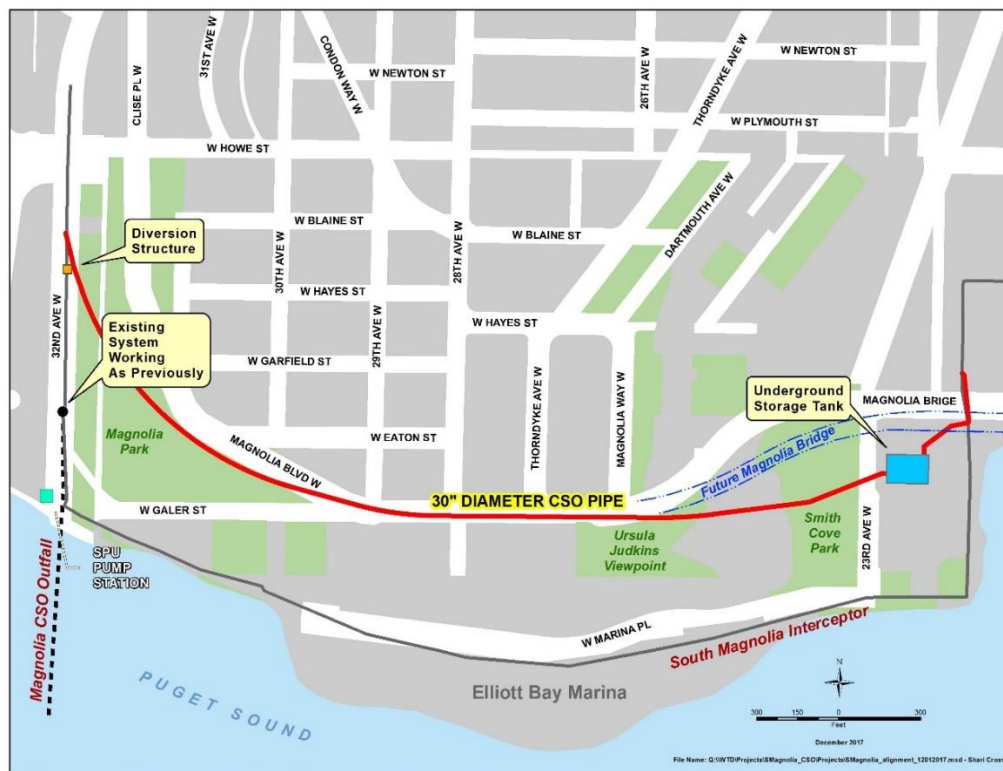
- 32nd Ave. W. to be closed between Clise Pl. W. and 33rd Ave. W.
- The contractor to deliver and assemble pipe sections in this area. To reduce impacts to residents on 32 Ave. W., the pipe sections will be stored at the Port of Seattle before assembly.
- Weekday construction hours as construction ramps up are expected to extend from 7 a.m. to 6:30 p.m.; however, crews may work until 10 p.m. to maintain progress as needed.
- Saturday construction hours from 9 a.m. to 6:30 p.m.
- Flaggers and signs to direct traffic and pedestrians around the work zone

Construction activities at Smith Cove Park:

Soil freezing equipment is on site; people may see large liquid nitrogen tanks in the fenced work area. Crews will work overnight in the exit pit after the ground is frozen.

People visiting the Smith Cove Park can expect:

- **Extended 24- hour construction from March 2nd to March 22nd:**
- Around the clock work is expected on weekdays. Work may extend into the weekend.
- Construction equipment located onsite, including a large drill rig, jackhammer and soil freezing equipment
- 24-hour surveillance while soil freezing equipment is present
- Increased light, noise and vibrations typical of a construction site
- Fog near the excavation because of soil freezing equipment
- Flaggers and signs to direct traffic and pedestrians around the work zone, as necessary
- The northern athletic field will remain open for use.
