Restoration Continues

Over the past couple weeks, project neighbors in Magnolia may have noticed restoration activities happening throughout the project area. The County's contractor is completing pipe connections, restoring structures, and preparing to resume overflow diversion operations in time for the wet weather later this fall. Please continue reading for more information about what to expect in coming weeks and how to stay informed.

Shoring removal and reseeding at Smith Cove Park

Earlier this month, King County's contractor removed shoring around the pit at Smith Cove Athletic Fields. In the coming weeks, King County will work with the City of Seattle to determine a date to reseed the grass. We will update project neighbors once the work is scheduled.

What you can expect:

- Work hours: From 7:00 a.m. until 7:30 p.m. Monday-Friday. No work on weekends is anticipated.
- Flaggers and signs to direct traffic and pedestrians around the work zone, as necessary
- Once reseeded, the southern portion of the athletic field will be protected to allow grass to get established
- The northern athletic field will remain open for use



Surveying at West Galer Street

Last week, King County's geotechnical consultant completed this phase of surveying on West Galer Street. As the project team is evaluating data from tomography, there will be a break in work on West Galer Street.

Shoring removal and restoration at 32nd Avenue West

This week, the County's contractor began removing shoring around the excavation at the diversion structure on 32nd Avenue West. This work is anticipated to take three to five days to complete. We will keep you up to date on activities as crews make progress.

What you can expect:

- Work hours: From 7 a.m. until 5 p.m. Work may extend later as needed to accommodate the pipe connection, pressure test and backfill of excavations
- Traffic flow past the work site will be maintained. Watch for flaggers and please drive slowly to protect crews, other drivers, and pedestrians
