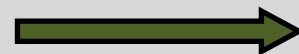
Street restoration work on 17th St. SE begins Monday, November 4; Traffic impacts on A St. SE November 6 through 8

King County contractors are continuing construction on the Stuck River Trunk sewer which will provide sufficient capacity to meet Auburn's needs through 2050 and reduce the chance of sewer backups into homes and streets.

Work Activities

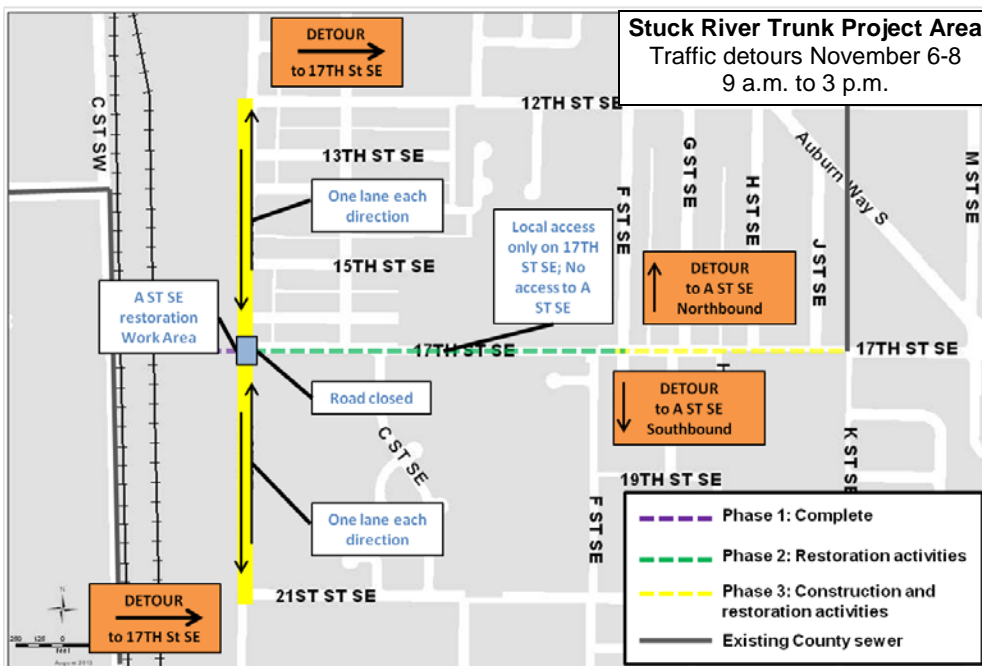
Street restoration on 17th St. between A St. SE and K St. SE begins Monday Nov. 4. Crews will begin grinding, grading and paving activities to restore the street to City of Auburn standards. Restoration work is expected to be complete by mid-November. **Traffic will be reduced to one lane Nov. 6-8, from 9 a.m. to 3 p.m. to accommodate restoration on A St. SE. Traffic restrictions and detours will be in place (see map).**

Curb and gutter restoration on the south side of 17th St. SE near K St. SE continues. The contractor will notify residents if individual driveway access will be restricted.

Open-trench pipe installation continues. Crews are currently working on phase 3, near K St. SE.

WHAT TO EXPECT DURING CONSTRUCTION:

- Work hours from 7 a.m. to 6 p.m. weekdays
- Single lane closures in work areas during construction
- **Nov. 6 through 8 from 9 a.m. to 3 p.m.:**
 - One lane of traffic each direction on A St. SE
 - Detours via F St. SE, 12th St. SE and 21st St. SE to/from A St. SE and 17 St. SE
- Parking and pedestrian restrictions
- Cones, signs and flaggers will be used to manage traffic flow and local access
- Extra travel time through work areas
- Noise and other activity typical of a construction site: work crews, dust, trucks, heavy machinery and equipment



Please use caution when traveling through work areas. Follow flagger instructions and traffic cones and signs, plan for travel delays.
