Construction activities to increase next week on Southeast 264th Street

Las actividades de construcción comenzarán la próxima semana en Southeast 246th Street

Hoạt động xây dựng sẽ tăng vào tuần tới trên 264th Street phía Đông Nam

King County contractors continue to install the Kent East Hill Diversion pipeline underneath Southeast 264th Street. The new pipeline will help provide sufficient capacity to meet Kent's needs through 2050 and reduce the chance of sewer backups into homes and streets.

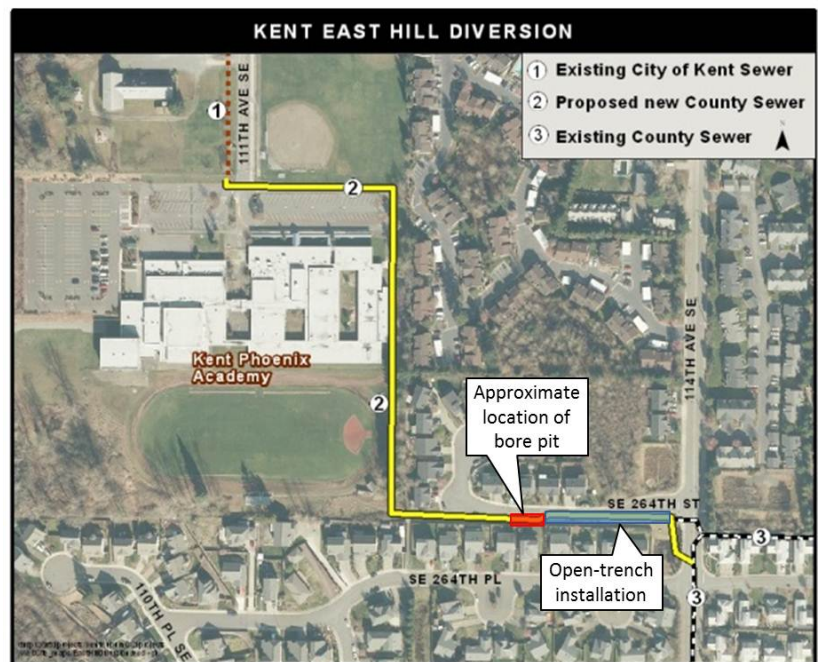
PROJECT UPDATE:

Construction activity will increase the week of October 14 as crews begin the final phase of work on Southeast 264th Street.

- **Monday, October 14 concrete trucks will be onsite** to grout the new sewer pipe in the bore pit (*see map*). Crews will then begin revising the shoring to allow for installation of manholes and completion of the pipeline prior to filling and restoring the pit.
- **Open-trench pipe installation begins next week.** Crews will excavate the south side of the SE 264th St to install sewer pipe between the bore pit and 114th Ave SE (*see map*). **Expect increased truck traffic, noise and high levels of activity.** Pipe installation is expected to be completed by mid-November. This work is weather dependent.
- **Restoration activities** on SE 264th St and school property are expected to be completed by the end of the year, weather dependent.
- **Settlement monitoring inspections** continue on Southeast 264th Place during construction.

WHAT TO EXPECT DURING CONSTRUCTION:

- Work hours from 7 a.m. to 6 p.m. weekdays
- Single lane closures in work areas
- Parking and sidewalk restrictions
- Cones, signs and flaggers will be used to manage traffic flow and local access
- Increased travel time when driving through the work area
- Noise and other activity associated with a construction site: work crews, dust, trucks, heavy machinery and excavating equipment



Expect lane restrictions and parking limitations in work zones along Southeast 264th Street. Please use caution and obey flaggers and posted traffic signs.

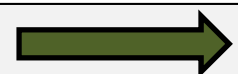
