

Finishing the Project: Final paving and removal of equipment begins June 25

Next week, crews will begin final paving work on S.E. 264th St. and the school property. King County contractors completed construction of the Kent East Hill Diversion pipeline in January 2014. The new pipeline will help provide sufficient capacity to meet Kent's needs through 2050 and reduce the chance of sewer backups into homes and streets.

PROJECT UPDATE:

Final paving activities begin next week.

Next Wednesday, June 25, crews will begin final paving work on portions of S.E. 264th St, the intersection of S.E. 264th St and 114th Ave SE and the Kent Phoenix Academy property (see map to the right).

Paving activities include grinding the existing pavement and then laying down new pavement. Crews will then stripe lanes and complete the restoration of the roadway to City of Kent standards. This work is expected to last up to five days. Crews will not work weekends.

This is the final step and once complete, all equipment and signs will be removed from the project area. We thank you for your patience during construction.

Please use caution when traveling through work areas. Follow flagger instructions, traffic cones and signs.

WHAT TO EXPECT DURING FINAL PAVING:

- Normal work hours are weekdays from 7 a.m. to 6 p.m.
- Single lane closures in work areas
- Parking and sidewalk restrictions
- Cones, signs and flaggers will be used to manage traffic flow and local access
- Increased travel time through work areas
