Construction Progress Update

King County is working with the contractor to complete pipe installation and pump station upgrades as efficiently and safely as possible. We appreciate your patience as we complete this important work. Please read on for an update on project progress.

Green roof installed at Sunset Pump Station

Last week, crews finished installing the green roof on Sunset Pump Station (see below). The green roof will reduce runoff and improve water quality.



SE 35th PI: pipe installation nearly complete, restoration work beginning

We're happy to report that crews are nearly finished installing pipe on SE 35th PI via open cut. Crews have recently started restoration work, including repaving. This work will require the continuation of single-lane closures on SE 35th PI. Please pay attention to flaggers and signage to navigate the area safely.

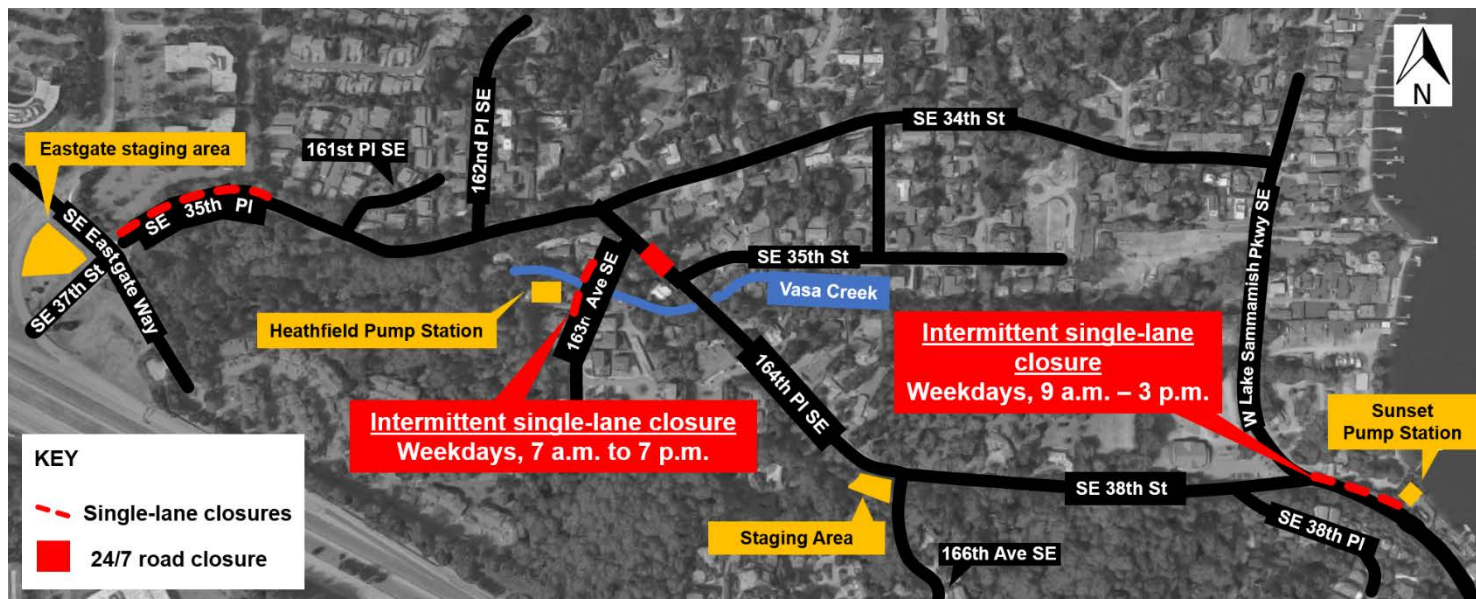
164th PI SE: pipe installation continues, access to SE 35th St temporarily re-opened

Crews recently finished installing pipe underneath Vasa Creek via jack-and-bore and have temporarily reopened a previously-closed section of 164th PI SE. Access to SE 35th St from 164th PI SE is now open. Both lanes on the northwest side of the intersection of 164th PI SE and SE 35th St will remain closed 24/7.

The schedule and duration for construction is tentative and is subject to change as work progresses. We will continue to provide email notices with updates on timing of specific construction activities.

What to expect during construction

- **Work hours**
 - Mondays through Fridays, 6:30 a.m. to 7 p.m.
 - **Please note:** Equipment will not start until 7 a.m., per the City of Bellevue Noise Ordinance
- **Closures**
 - **164th PI SE:** One full 24-hour road closure near SE 35th St and 163rd Ave SE
 - **SE 35th PI:** Single-lane closures
 - **163rd Ave SE:** Intermittent single-lane closures
 - **W Lake Sammamish Pkwy SE:** Intermittent single-lane closures
 - **Please note:** Flaggers and signage will assist drivers in detouring around closures. Access to homes and driveways will be maintained and prioritized for the duration of the closures.
- **Increased noise and vibrations:** Neighbors can expect noise and vibrations from excavation for pit creation, shoring, boring machines, Vector trucks, pipe installation, and generators.
- **Parking impacts:** Select street parking will be removed during this phase of work. Please adhere to the no parking signs posted by the contractor.
- **Access maintained for services:** Access will be maintained for emergency services, waste pickup, and mail delivery.
