PROTECTING PUBLIC HEALTH AND THE ENVIRONMENT ON VASHON ISLAND

24/7, 365 days a year, King County Wastewater Treatment Division (WTD) is working hard to protect public health and the environment by treating wastewater. Wastewater is the water that goes down the drain in your home or business.

On Vashon Island, King County operates a treatment plant, four pump stations, and four miles of underground pipe. If your home or business is connected to this system, the water you use travels down your drain to pipes operated by the Vashon Sewer District. The Sewer District's pipes connect to King County's Wastewater Treatment Plant. After treatment, we send the clean water into Puget Sound.

We estimate that the total population served by King County's wastewater treatment system on Vashon Island is approximately 1,150 people.



How the Vashon Treatment Plant works


Wastewater is pumped through King County and Vashon Sewer District pipes to the County's Treatment Plant on SW 171st St.

1 Trash removal



Screens are used to **remove** large debris and trash.

2 Oxidation Ditch



Wastewater **travels** to a tank where microorganisms and bacteria **eat** organic material and contaminants.

The solid material is rich in microorganisms and bacteria. Solids are **cycled** back and forth between the oxidation ditch and the clarifier. Most of the solid material is **reused** to help break down contaminants.

3 Clarifier Tanks



Wastewater goes to big tanks where the solid material **settles** to the bottom of the tank, leaving clear water at the top.

4 Disinfection



The clear water is **disinfected** using ultraviolet (UV) light

5 Clean Effluent



Clean water leaving plant!

Wastewater coming into plant

Clean water is **released** into Puget Sound.

Solids to South Plant



A small amount of solid material is periodically removed from the bottom of the clarifier to prevent buildup. This excess waste is loaded into tanker trucks and taken to South Treatment Plant in Renton for recycling.

How the Beulah Park/Cove Beach community septic system works

The residents of Beulah Park and Cove Beach are part of a community septic system. King County WTD operates the community septic system. It is not connected to the Vashon Treatment Plant. Instead, wastewater is treated using a series of septic tanks, sand filters, ultraviolet disinfection, and slow percolation through soil.



1 Water goes down the drain at each home and into a series of sewer pipes.



2 King County's vacuum pumps on 137th Ave SW pull sewage through the pipes.



3 Sewage is treated using a series of sand filters and septic tanks. Pollutants settle out in the tanks. Solid material is consumed by good bacteria in a sand filter. UV light is used to disinfect treated water.



4 Water is 98% cleaner than when it entered septic tanks. It is pumped to the Beulah Park drain field. The water continues to be cleaned by slowly moving through the soil.
