


Collaboration among the courts

A team of 2 interpreters is required for:

- <u>Simultaneous</u>: for proceedings longer than 1 hr.
- <u>Consecutive</u>: for proceedings longer than 2 hr.

Interpreter Web Application

- Application allows clerks, one administrative staff person and interpreters to efficiently manage the scheduling and coordination of interpreter service assignments
- Application allows interpreters to sign up for unassigned jobs based on their availability and to use a personal calendar for an easy review of their assigned jobs
- System is easy to use and automates functions such as notification of assignment and assignment changes to all parties involved
- System allows a user to see at a glance all interpreters needed for a particular language or division and whether or not an interpreter has been assigned

Challenges

- Increasing rate request from interpreters. Particularly in languages where there are a limited number of Certified/Registered interpreters
- Scheduling interpreters for rare languages
