As part of a substantial remodel of an existing home, a new drainfield and reserve drainfield are required. This will involve crossing a Category IV pasture wetland with a drainfield line. The portion of the drainfield line that will cross the wetland is approximately 226 feet. A channel approximately 1 foot wide will be excavated; drainfield pipe will be laid, and the area will be backfilled and restored to it's former condition. This SEPA checklist addresses this particular aspect of the project; the remainder of the single family home remodel is exempt from SEPA.

- The total area within the wetland that will be affected is approximately 468 square feet. The pipe will be laid within the trench, packed with gravel, and backfilled with native soils.
