Project Description: 1) A conditional use permit to allow establishment of Social Services and Outpatient Medical /Dental Office land uses in a new 26,500 GSF building in a residential zone (R-18) to serve the White Center Community; and 2) A Zoning Variance to allow a building setback of 18 feet rather than the required 30 feet from a property line. This land use proposal is part of an integrated site development that includes a second building for low income housing units.

Permit requested in this application: Conditional Use Permit (CUP) & Zoning Variance (VARI) Environmental review is required, and relevant environmental documents are available on-line at www.kingcounty.gov/permits, or at the above address.

Consistency with applicable County plans and SEPA regulations: This proposal will be reviewed for compliance with all applicable King County codes including Roads Standards, Surface Water Design Manual, Zoning, Grading and Critical Areas Codes.

You are receiving this notice because King County property records indicate that you own property within 500 feet of the proposed project described above. The Department of Local Services, Permitting Division (DLS-Permitting) will issue a written decision and SEPA determination on these applications following a **21-day public comment** period which ends **January 3**, **2021**. Written comments on this application must be submitted to DLS-Permitting at the address above. A public hearing is not required for this application prior to the DLS-Permitting decision. However, the decision & SEPA determination may be appealed to the King County Hearing Examiner, who would conduct an appeal hearing prior to making a decision on the appeal. Details of the appeal process will be included in the forthcoming notice of decision.

This may be the only opportunity to comment on the environmental impacts of the proposal. The responsible official has a reasonable basis for expecting to issue a SEPA Determination of Non-Significance (DNS) on this project. As such, the optional DNS notice process is being used pursuant to WAC 197-11-355. The project review process may incorporate or require mitigation measures regardless of whether an EIS is prepared.
