This project includes ABC clearing and grading restoration of wetland and wetland buffer under King County Code Enforcement Case No. ENFR19-0721. The general scope of work for the project includes restoration of wetland impacts (3,043 sf) and wetland buffer impacts (3,008) for a total of 6,051 sf of restoration. Work includes restoration of pre-construction soil conditions, revegetation of the affected area with native plants, installing critical area fencing and signage, and three years of monitoring.

<u>Background:</u> In August 2019, King County staff observed unpermitted clearing and grading within the site. The clearing and grading was undertaken by the current landowner and occurred west of the existing single-family residence near the western property line. King County subsequently opened a code enforcement case for the unpermitted work under ENFR19-0721.

The unpermitted clearing and grading occurred during the summer of 2019 and resulted in the removal of existing vegetation and modification to topographic contours within a localized area in the west-central portion of the site. The purpose of the work was to create a flat area adjacent to an existing gravel driveway for a future pole barn. A small skid-steer bobcat was initially used to remove existing vegetation and re-distribute soils within the affected area. An excavator was then used to bury a large cedar stump as well as to set and smooth the final re-contoured ground surface. All construction access was via the existing driveway located adjacent to the work area. Upon review of the area by King County staff, it was determined that construction of a pole barn was not feasible.



Existing upland soils that have been placed into the Category II wetland and buffer will be removed. Work will occur along the western property line near the center point of the site.

Yes. Erosion is possible during construction prior to final site stabilization.

g. About what percent of the site will be covered with impervious surfaces after project construction (for example, asphalt or buildings)?

None. Site will be fully restored to an undeveloped condition.

A temporary erosion control (TESC) has been prepared for the project. All TESC will be per current King County standards. TESC measures will be installed prior to start of work and will be properly maintained and monitored during the entire construction period.

Exhaust emissions from construction equipment will be present during construction. The completed project will not emit emissions.

Construction equipment will have standard exhaust emission control devices installed.

A Category II wetland exists within the project area. The wetland drains to an unnamed Issaquah Creek tributary located south of the site.

Yes. Soil will be removed from 6,051 sf of the Category III wetland to restore pre-construction grades and contours. Native plants will be installed within and adjacent to the wetland and buffer to re-vegetate the affected area.

3) Estimate the amount of fill and dredge material that would be placed in or removed from surface water or wetlands and indicate the area of the site that would be affected. Indicate the source of fill material.

Soil will be removed 6,051 sf of the Category III wetland to restore pre-construction grades and contours. The exact amount is not known. Fill soils will be removed down to the underlying native soils.
