

SEPA ENVIRONMENTAL CHECKLIST

Purpose of checklist:

This information is also helpful to determine if available avoidance, minimization or compensatory mitigation measures will address the probable significant impacts or if an environmental impact statement will be prepared to further analyze the proposal.

You may need to consult with an agency specialist or private consultant for some questions.
