The purpose of the emergency bulkhead project was to replace an existing deteriorated creosote timber bulkhead to prevent further erosion of the upland. The bottom of the bulkhead was rotted allowing material to erode from behind. The creosote timbers and piling supporting the bulkhead were also rotted. The replacement angular rock bulkhead was built in the same footprint as the previously existing bulkhead. The piling project will include replacement of two creosote pilings and two untreated pilings with 10" steel pilings.

Almost flat directly behind the bulkhead. Bulkhead Project did NOT affect any steep slopes. The Piling Project will not affect any steep slopes.

Everett-Alderwood gravelly sandy loams, 6 to 15 percent slopes

There are no current surface indicators of unstable soils. Soil was eroding from underneath the previous, failing bulkhead because of wave-driven erosion.

e. Describe the purpose, type, total area, and approximate quantities and total affected area of any filling, excavation, and grading proposed. Indicate source of fill.

The purpose of the excavation of the material behind the existing timber bulkhead was to remove material in order to place large angular bulkhead rock. The replacement bulkhead is approximately 150 linear feet and required approximately 60 CY of bulkhead rock and 40 CY of quarry spalls from an upland source.

f. Could erosion occur as a result of clearing, construction, or use? If so, generally describe.

No. The bulkhead replacement was subject to best management practices and mitigation measures as required by the WDFW Expedited HPA.

Short term air emissions from a tug, excavator and front loader occurred during construction of the bulkhead project. Very short air emissions from a tug and pile driver will occur for the piling project.

Low sulfur fuel will be used and no idling of equipment will be allowed.
