Removal of existing fully decked section of pier amounting to 25x33 and 8x17 (961SF) with 32 associated creosote-treated wood piles. Replace with 25x33 (825SF) 100% grated pier supported by 8 10-inch diameter galvanized steel piles.

This will result in a decrease of 24 piles, minimize the SF of piles (15-inch diameter creosote-treated wood piles down to 10-inch diameter galvanized steel), reduce square footage by 136SF, and introduction of 100% grated surface.
