Project Description: Replace 83 linear feet of an existing creosote-treated, woodpile bulkhead with a rock bulkhead. The proposed bulkhead repair will be in the same footprint as the existing bulkhead. Anchor three existing wood logs on the beach. Plant native vegetation per the planting plan. Remove approximately 10 cubic yards of rocks from the beach. 25 cubic yards of beach nourishment gravel will be added to the beach waterward of the bulkhead. Redeck a section of the existing wood deck landward of the bulkhead. Reinstall an existing davit.

Permit requested in this application: Shoreline Exemption

Consistency with applicable County plans and regulations: This proposal will be reviewed for compliance with all applicable King County codes including the Shoreline Master Program (KCC 21A.25) and Critical Areas (KCC 21A.24).

King County Code requires notification of property owners within at least 500 feet of the project proposed above, so they can obtain additional information about the proposal and comment if they wish (KCC 20.20).

The Department of Local Services, Permitting Division will issue an Environmental Threshold Determination pursuant to the State Environmental Policy Act (SEPA) on this application following a **21-day public comment period** which ends on **December 9, 2021**. The responsible official has a reasonable basis for expecting to issue a SEPA Determination of Non-Significance (DNS) on this project. As such, the optional DNS/MDNS notice process is being used pursuant to WAC 197-11-355. The project review process may incorporate or require mitigation measures regardless of whether an EIS is prepared.

This may be the only opportunity to comment on the environmental impacts of the proposal. Written comments on this application must be submitted to Permitting Division at the address above by the end of the comment period.
