The King County Code requires notification of property owners within at least 500 feet of the project proposed above, so they can obtain additional information about the proposal and comment if they wish (KCC 20.20). The Dept. of Local Services, Permitting Division (PD) will issue a SEPA Threshold Determination and a decision on this application following a minimum **<u>30-day public comment period</u> ending April 8. 2021.** Written comments on this application must be submitted to PD at the address below. A public hearing is not required for this application prior to the PD decision. However, the PD decision may be appealed to the Shoreline Hearings Board, who would conduct an appeal hearing prior to making a decision on the appeal. The SEPA Threshold Determination may be appealed to the County Hearing Examiner. Details of the appeal process will be included in the notice of decision.
