**Description of Proposal:** 

A proposed ordinance to amend the shoreline development regulations in King County Code Titles 20 and 21A to be consistent with changes in state law and to change regulations for aquaculture and net pens. Amendments may affect the following areas of regulation: definitions, shoreline jurisdiction, commercial net pens, aquaculture, wetland rating methodology, wetland buffers, restoration

permit requirements, allowed alterations, and aquatic areas.

These changes are being made as a result of the required 2019 periodic review of King County's Shoreline Master Program (SMP),

in accordance with the State Shoreline Management Act.
