You are receiving this notice because King County property records indicate that you own property within 2500 feet of the proposed project described above or have asked to be notified of development proposals related to this site.

The Department of Permitting and Environmental Review (DPER) will be making a recommendation and issue a written SEPA threshold determination on this application following a **21-day public comment** period which ends **JANUARY 29, 2018**. Written comments on this application and likely SEPA MDNS must be submitted to DPER at the address above. A public hearing before the King County Hearing Examiner is required for this application. Notification of the public hearing date will occur prior to the scheduled hearing date. DPER will issue a report and recommendation to the Hearing Examiner prior to the scheduled public hearing. Following the close of the public hearing, the Hearing Examiner will issue a written decision which may be appealed to the Metropolitan-King County Council. Details of the appeal process will be included in the Notice of Recommendation.

This may be the only opportunity to comment on the environmental impacts of the proposal. The responsible official has a reasonable basis for expecting to issue a SEPA Mitigated Determination of Non-Significance (MDNS) on this project. As such, the optional DNS/MDNS notice process is being used pursuant to WAC 197-11-355. The project review process may incorporate or require mitigation measures regardless of whether an EIS is prepared.
