6. SCOPE AND DISCLAIMER

Records filed to and managed within the KC ERMS will be dispositioned from within the KC ERMS and documentation will be maintained by the Records Management Program. Transitory records may be destroyed within the normal course of agency business without the use of any destruction forms.
