



## Complaints Reported by Community Members and Sheriff's Office Employees

**Bottom line:** There were 18 complaints reported in 2019 in District 2, and Internal Investigations Unit (IIU) classified 17 of those complaints as Inquiries, or serious complaints. Those 17 complaints included 26 allegations of misconduct, with the top allegation being courtesy. IIU sustained one courtesy allegation and did not sustain the other seven allegations.

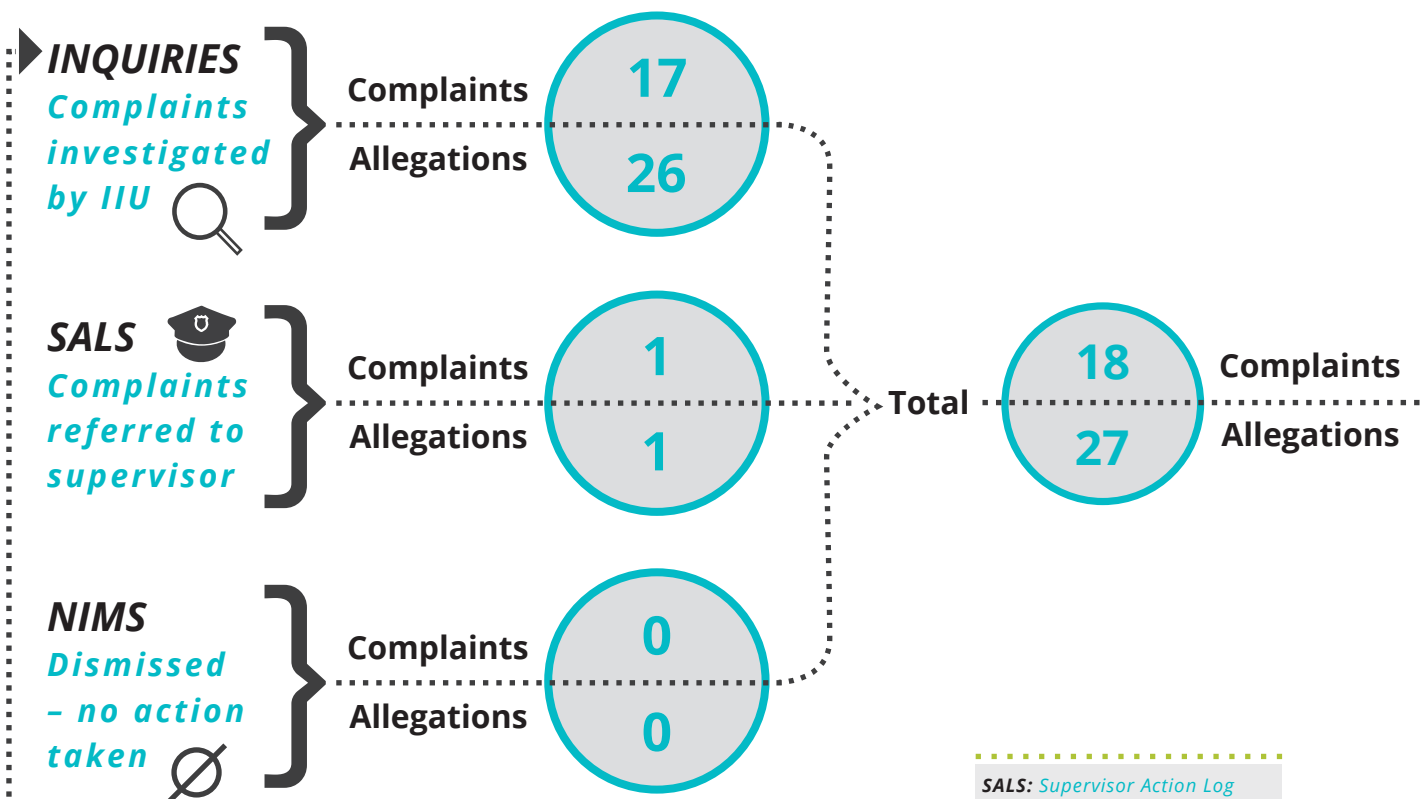

IIU2019-284	Courtesy (1)	Community member alleged deputy intimidated and bullied their family members at a park.	Sustained	Certified
IIU2019-297	Courtesy (1)	Community member alleged deputy didn't do his job correctly, wasn't professional, and when asked to serve a protection order, deputy threw it on the ground, refused to serve it, and laughed.	Exonerated	Certified
IIU2019-351	Courtesy (1)	Community member alleged that as they were carrying groceries through a parking lot, a police car pulled in, drove up next to them, and started flashing its headlights at them; community member felt uncomfortable and intimidated by deputies.	Unfounded	Certified
IIU2019-378	Courtesy (1)	Community member alleged deputy was rude to them when they asked a question.	Exonerated	Certified
IIU2019-426	Courtesy (1)	Community member alleged that while they were riding their bicycle on the street, a transit deputy chastised them for not riding on the right side of the lane and alleged deputy does not know bicycle law.	Unfounded	Certified
