Where is your annual fee estimate?

Annual fee estimate letters coming later this year – in late summer or early fall.

In the past we sent estimates to customers in May before new fees took effect in July. Now KCIW fee changes take effect in January. We are planning to send the estimates well in advance of the next fee change in January 2019.



In 2018, KCIW is working to update the fee structure.

Updating Industrial Waste Fees: Next Steps



As reported in <u>our last two newsletters</u>, KCIW has been working on a proposal to update the structure of its fee system. A two-step decision-making process is starting in summer 2018. First the King County Council will consider an ordinance to update the King County Code. Pending Council approval of the ordinance, the Department of Natural Resources will develop a Public Rule. <u>Learn more about updating fees</u>.

Industrial Waste Fees for Surcharge Customers

Currently the Surcharge fee covers the cost of treating concentrated waste and the cost of Compliance Monitoring and Administration. Under <u>a proposal to update Industrial Waste Fees</u>, the current Surcharge Fee would be separated into two different fees:

- A Surcharge Fee for treating concentrated waste
- A separate Compliance Monitoring and Administration Fee.

Change brings more transparency, making it easier for customers to see what they are paying for. Within the next two years, customers could begin to see two line items on their bills where they used to see just one. Learn more about the surcharge fees.

Companies that violate clean water rules receive penalties

How to Avoid Penalties: Late submissions are a frequent and preventable reason for violations and fines. Plan ahead. File your applications and reports on time.

In 2017, your work to keep industrial wastewater clean helped KCIW meet federal regulations for water quality. In addition, our biosolids consistently met the strictest U.S. Environmental Protection Agency standards for concentration of metal. By keeping metals out of wastewater, you help keep it out of the environment.
