

# **Summary of Engineering and Planning Subcommittee June 5, 2014 Meeting for MWPAAC General Meeting on June 25, 2014**

## **1. Conveyance System Improvements (CSI) Update for 2015**

King County staff continued the discussions of the 2015 Conveyance System Improvements Update process. Meetings with individual agencies will occur in Summer 2014, and will include discussion of the individual agencies' flow projections compared to King County's flow projections from the decennial monitoring. According to KC Staff, if a project was in the 2007 Update and the need is still there, the project will continue in the next update. Prioritization factors will continue to be discussed at the August E&P Subcommittee meeting. Of the 7 high-priority projects identified in the 2007 Update, 1 project is complete and 5 are in progress.

## **2. Regional Wastewater Services Plan (RWSP) Review Report**

E&P Subcommittee has formed a task force to identify which policies should be discussed for possible revision, as well as propose new policies that may be considered by the King County Executive and the Regional Water Quality Committee (RWQC) for potential adoption. The task force members are Paul Bucich (Bellevue), Dave Christensen (Renton), Susan Saffery (Seattle), Scott Thomasson (Redmond), and Lisa Tobin (Sammamish Plateau). King County staff members will be Sharman Herrin, Mark Buscher, and Debra Ross.

## **3. Water Quality Assessment and Monitoring Study**

The Water Quality Assessment and Monitoring Study is evaluating the water quality in water bodies that receive discharges from Combined Sewer Overflows (CSOs). The study will ensure that investments in CSO prevention/treatment facilities are well-planned and timed to optimize water quality benefits. The Science and Technical Review Team, which includes academic and scientific experts, should complete their evaluation of the data gathered and identify any data gaps by the end of 2014.
