## 2. Wastewater Treatment Division Director's Report- Pam Elardo, P.E., Director, Wastewater Treatment Division

#### Bond Sales

In June and July, in two separate bond sales, King County's Wastewater Treatment Division (WTD) refinanced \$271 million in sewer revenue bonds, which will save the utility \$37.3 million. The bond sale completed on July 21 will achieve approximately \$32 million of savings over the next 20 years based on an interest rate of 3.36 percent.

A previously completed bond refinancing of \$75 million on June 30 resulted in \$5.3 million of immediate cash savings based on an interest rate of 4.2 percent for bonds with an average life of 30 years. Since 2000, various refinancings of King County's bonds have saved the utility almost \$300 million.

#### **Georgetown CSO**

We are making very good progress in meeting consent decree requirements for our CSO projects. You may recall that in 2012-13, the King County Auditor performed an audit of the CSO program. Since that time, there has been an additional audit of the Brandon-Michigan or Georgetown CSO project.

We anticipate the audit will be released early September. Executive's Office is still drafting their response. WTD concurs with the recommendations and had already begun implementing many of them. We will provide MWPAAC with a copy of the audit and response as soon as it is released.

Georgetown is a large basin with a lot of volume to control. WTD is in the process of reevaluating some alternatives to control this basin to make sure we select the best alternative.

#### Local Companies Recognized for Environmental Stewardship

Each year, the Industrial Waste Program, which operates as part of King County's Wastewater Treatment Division, recognizes local facilities whose wastewater pretreatment efforts, permit compliance, and excellent record keeping contribute to regional pollution prevention goals.

Safeway, Inc. Beverage Plant in Bellevue earned a Commitment-to-Compliance Award for meeting discharge permit standards every month for five consecutive years with no violations of any kind. The company also received the award in 2000.

Forty-four companies earned Gold Awards for compliance with wastewater discharge regulations every month in 2013 with no violations. The program presented Silver Awards to 28 companies for having no King County monitoring violations in 2013.

<u>King County Wastewater Treatment Plants Earn National Environmental Awards</u> WTD earned several Peak Performance Awards from the National Association of Clean Water Agencies for outstanding compliance with state and federal permit requirements.

The South Treatment Plant in Renton and the West Point Treatment Plant in Seattle each received the Platinum Peak Performance Award. The award honors multiple consecutive years of compliance with effluent limits established under the NDPES permit.

To date, South Treatment Plant has attained 16 years of 100 percent permit compliance with its effluent limits, and West Point Treatment Plant has attained 12 years of compliance.

King County's Vashon and Carnation treatment plants received Gold awards from NACWA for 100 percent compliance for effluent limits within the past calendar year.

The Brightwater Treatment Plant, which came online in 2011, earned its first ever Gold award.

# 4. Overview of the Liquid Assets Recommendations to the WTD Division Director- Pam Carter, Chair, Working Group (Action Item)

Pam Carter, Chair of the Working Group on Liquid Assets, presented an updated proposal with changes in response to members' comments from the June 25 meeting.

The floor opened for changes to the proposal.

- Motion to add limitation language of 30% back in the proposal with the majority of the review committee to override based on the quality of the applicant. Motion denied by majority vote.
- Motion to include language that states WTD and MWPAAC will conduct a 5-year review of the program and the process. Motion passed 15-1
