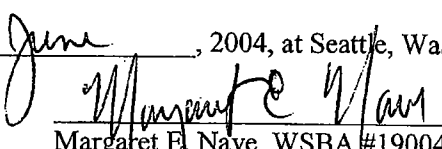
17 COMES NOW Norm Maleng, Prosecuting Attorney for King County, Washington, by and

OMP GOALS (Revised 12-14-04)

1. The county supports long-term mutually beneficial full cost recovery district court contracts with cities.
2. The county supports providing access to the district court in the locations that it currently owns (except the District Court should have only one location in the City of Kent and that should be at the RJC—at least 3 additional courtrooms should be assigned to the District Court at the RJC), and supports partnerships with cities to insure the viability of those locations.
3. The county supports improvement of service levels by the district court to all of its users, including the cities.
4. The county supports improvement of access to ~~specialty courts and jail alternatives to contract cities.~~ *Problem solved.*
5. The county supports coordination and integration of the district and superior courts.
6. The county supports consolidation of the state criminal caseload at 3 main locations (RJC, KCCH, and one Eastside Courthouse) and access for the public at other locations.
