The following revised assignment of filing jurisdiction for police agencies filing state criminal and infraction matters into King County District Court supercedes all previous General Administrative Orders for filing of state criminal, criminal traffic, fish and wildlife, alcohol related offenses and state infraction cases into King County District Court.
