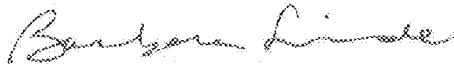
For all cases listed in Attachment A, the Court has taken the following steps:

- The hearing was continued on the case but not calendared within the 120 days; or
- The case is a duplicate on the DCH and the case number is off by one letter or number on the proof filed by the defendant.
