ESIT-DHH Process Overview

Full-Service Agency's Process for DHH Child Moving Forward:

- Inform Family & Support Choices
- Alert DHH Agencies of scheduled dates to be ready
- Move child/family through process without delays

1 Referral 2 Intake 3 Eval or Assess 4 Initial IFSP 5 ESIT 6 IFSP 7 Transition

Once DHH Agency is Chosen:

Include DHH Provider as full team member in all steps

Family is referred to ESIT

DHH FRC includes DHH Provider in all steps of the ESIT/DHH Process.

- 1. Cross-Agency team members attend Eval/Assess
- 2. DHH FRC schedules IFSP + includes DHH Provider

/ Transition

- 1. DHH FRC checks-in w/Family.
- 2. If family has not made a choice 2wks before IFSP—offer more than 1 DHH Agency Option.
- 3. DHH FRC + DHH Agencies remain in communication

IFSP Services:

- FRC Only
- IMH
- Other
 Recommended
 Services
- Connect to Guide By Your Side

DHH FRC checks-in with family regularly:

- Are services meeting child's needs?
- Keep open door to begin DHH services
- DHH FRC documents attempts & developmental progress
