# Program Overview & Monthly Update

Bryan Fry gave a brief overview regarding the King County Veterans Program. He discussed the current open position at the Renton Veterans program and also provided a brief job description.

Bryan discussed the client count and how clients are tracked in the database for job searches; employment placements have an average starting wage of \$20.20. KCVP has a 90 day follow up after employment; the retention in job placement has been very successful.

Due to the short staffing at KCVP, the computer lab is open and being utilized by veterans. KCVP staff is available to support our clients with resumes, job search and training.

Burial Assistance amount was increased to \$750.00. In January 2017, the program served 9 families with assistance totaling \$6000.00.

- Contrast to 2016 compared to 2017, there is a slight increase in our traffic flow.
- Homeless Veterans connecting with the Seattle office are slightly higher than the Renton location.

Bryan presented a brief overview on the report given to KC Counsel Members on Veterans & Human Services Levy renewal.
